NTD: Policy on Reporting of Coordinated Human Services Transportation Data

- On March 4, 2009, FTA published a final policy on the reporting of coordinated human services transportation data to the NTD
- Transit agencies can report all demand response services to the NTD including trips provided by the provider either in whole or by a third party to the NTD (sponsored trips can now be reported)
- By reporting these trips to NTD, providers can receive more funding via the formula for the 5307 program
- Charter trips cannot be reported





New Freedom Policy Change

- FTA published a proposed NF policy change on January 26, 2009
- Policy expands the type of projects its considers to be “Beyond the ADA”
- New and expanded fixed route and demand responsive service in rural and small urbanized areas designed to meet the needs of individuals with disabilities is now eligible
- Comments were due on February 23, 2009; final rule has not been published





Section 5310 – End of the Year Performance Reports

- States are required to submit their program measures on behalf of their Section 5310 subrecipients as part of their annual program of projects status reports
- Reports are due by October 31 each year and should cover the 12-month
- Reports should be submitted in TEAM.
- The State should submit both quantitative and qualitative information as available on each of the following measures:
 - Gaps in Service Filled
 - Ridership

Coordinated Planning Grant Program Requirements

In order to receive 5310, 5316 and 5317 funds:

- DR letter from Governor on file
- Project was selected from a local coordinated plan
- Project selected through a competitive selection process
- Project in current STIP
- Program of Projects
- Approved State Management Plan

Coordinated Planning - Transfer of Funds

- JARC/NFP
 - Between small urban and rural apportionments
 - State must certify needs are being met from area transferred from
 - Small urban and rural apportionments to Section 5307 or 5311 apportionments
 - JARC/NFP requirements do not change
 - Direct recipients of the 5307 and 5311 programs can apply directly to FTA
 - New scope codes established for JARC/NF projects included within a Section 5311 or 5307 grant.





Coordinated Planning - Transfer of Funds

- JARC Only
 - Transfer small urban and rural allocations to large urbanized area, Statewide JARC program/plan must be in place
- Notify FTA of all transfers
- Allocation letter for all small UZAs intending to apply directly for 5316/5317 apportionments (after CS)





Coordinated Planning - Friendly Reminders

- TEAM:
 - In Project Details:
 - For 5316 and 5317 programs, briefly describe the competitive selection process
 - Reference approved SMP and provide FTA approval date (from letter)
 - Attach the Program of Projects (POP)
 - Include name of coordinated plan and page number of project or goal that project was derived from (option to attach plans)
 - Use correct scopes for programs (Appendix C & D of Program Circulars, ALI tree scope code, separate administrative code 610-00; 11.80.00 ADMIN)





Coordinated Planning - Friendly Reminders

- When possible, combine your FY07–09 JARC and NF program funds into ONE grant application (One for JARC, One for NFP)
- Have 5310, 5316 and 5317 Grant applications submitted no later than JULY 15, 2009
- Update your FTA representative throughout your process – KEEP US INFORMED!





JARC/NF Reporting Requirements

- States and DRs have received 3 emails regarding JARC/NF Freedom reporting
 - <http://ftajarcnf.cesnn.com/>
- FTA hired contractors to collect and analyze data
- States and DRs will submit information to a web-based system
- FTA suspended activity until after May 1 but DRs should start gathering information





JARC/NF Reporting Requirements

- Designated recipients will be asked to report on basic program elements, including geographic coverage and units of service provided.
- Designated recipients will be required to provide a brief profile for each JARC- or NF-supported service with the following information:
 - Service description - Include route name and/or # (as applicable)
 - Local evaluation process
 - Accomplishments/Success
 - Lessons learned
