Bay Area to nonattainment with the federal 1-hour ozone NAAQS. EPA did not assign the Bay Area a classification. Then on July 22, 1999 (64 FR 39416) EPA published a final rule assigning the area a nonattainment

classification on moderate for purposes of funding appropriation under the

Transportation Equity Act for the 21st Century (TEA 21), Congestion Mitigation and Air Quality improvement Program (CMAQ) only. This is NOT an
